



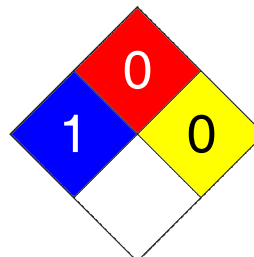

**Emergency Overview** CAUTION
