



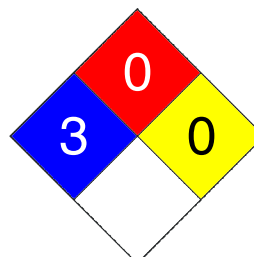

## 2. Hazards Identification

## 4. First Aid Measures

**First aid procedures**
